TERMS OF PRIORITY FOR THE SELECTION OF OCCUPIERS OF THE AFFORDABLE HOUSING UNITS

1. Place of development (five years or more):

- 1.1 was born in the town/village of Louth and lived for five years or more; or
- 1.2 has permanently resided for five years or more in the town/village of Louth; or
- 1.3 used to permanently live in the town/village of Louth for five years or more but has been forced to move away because of the lack of affordable housing; or
- 1.4 has been permanently employed in the town/village of Louth for five years or more.

2. Adjacent parishes of Keddington, Stewton, Legbourne, Raithby cum Maltby, Hallington, Elkington, and Brackenborough with Little Grimsby. (five years or more):

- 2.1 was born in one of the adjacent parishes of Keddington, Stewton, Legbourne, Raithby cum Maltby, Hallington, Elkington, and Brackenborough with Little Grimsby and lived for five years or more; or
- 2.2 has permanently resided in one of the adjacent parishes of; Keddington, Stewton, Legbourne, Raithby cum Maltby, Hallington, Elkington, and Brackenborough with Little Grimsby for five years or more; or
- 2.3 Used to permanently live in one of the adjacent parishes of; Keddington, Stewton, Legbourne, Raithby cum Maltby, Hallington, Elkington, and Brackenborough with Little Grimsby for five years or more but has been forced to move away because of the lack of affordable housing; or
- 2.4 Has been permanently employed in one of the adjacent parishes of Keddington, Stewton, Legbourne, Raithby cum Maltby, Hallington, Elkington, and Brackenborough with Little Grimsby for five years or more.

3. East Lindsey (five years or more):

- 3.1 was born in the district of East Lindsey; and lived for five years or more; or
- 3.2 has permanently resided in East Lindsey for five years or more; or
- 3.3 used to permanently live in East Lindsey for five years or more but has been forced to move away because of the lack of affordable housing ; or
- 3.4 has been permanently employed in East Lindsey for five years or more.

4. Place of development (less than five years)

- 4.1 has permanently resided for less than five years in the town/village of Louth; or

- 4.2 has lived in the town/village of Louth for less than five years but has been forced to move away because of the lack of affordable housing; or
- 4.3 has been permanently employed in the town of Louth for less than five years; or
- 4.4 needs to reside in the town/village of Louth to give or receive family care and support;

5. Adjacent parishes of, Keddington, Stewton, Legbourne, Raithby cum Maltby, Hallington, Elkington, and Brackenborough with Little Grimsby (less than five years)

- 5.1 has resided for less than five years in the adjacent parishes of Keddington, Stewton, Legbourne, Raithby cum Maltby, Hallington, Elkington, and Brackenborough with Little Grimsby; or
- 5.2 has lived in the adjacent parishes of Keddington, Stewton, Legbourne, Raithby cum Maltby, Hallington, Elkington, and Brackenborough with Little Grimsby for less than five years but has been forced to move away because of lack of affordable housing; or
- 5.3 has been employed in the adjacent parishes of Keddington, Stewton, Legbourne, Raithby cum Maltby, Hallington, Elkington, and Brackenborough with Little Grimsby for less than five years; or

6. East Lindsey (less than five years)

- 6.1 has resided for less than five years in the district of East Lindsey; or
- 6.2 has lived in the district of East Lindsey for less than five years but has been forced to move away because of the lack of affordable housing; or
- 6.3 has been employed in the district of East Lindsey for less than five years;

7. Housing Register

- 7.1 Anyone on the housing register.
